- General protective and hygienic measures:

The usual precautionary measures are to be adhered to when handling chemicals.

Wash hands before breaks and at the end of work. Do not inhale gases / fumes / aerosols.

- Respiratory protection:

Not necessary if room is well-ventilated. When used properly and under normal conditions, breathing protection is not required.

- Protection of hands:

The glove material has to be impermeable and resistant to the product/ the substance/ the preparation. Due to missing tests no recommendation to the glove material can be given for the product/ the preparation/ the chemical mixture.
